### **Context**

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum:

- Promotes the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and
- Prepares pupils at the school for the opportunities, responsibilities and experiences of later life.

### **PSHE**

At St Margaret's Academy, we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children's learning in this vital curriculum area.

The overview of the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects required under the Ofsted Inspection Framework, as well as significantly contributing to the school's Safeguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

### **Statutory Relationships and Health Education**

"The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education...They also make Health Education compulsory in all schools except independent schools. Personal, Social, Health and Economic Education (PSHE) continues to be compulsory in independent schools."

We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to your children’s needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education, shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements.

This programme’s complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

### What do we teach when and who teaches it?

#### Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

At St Margarets Academy we allocate a session a week to PSHE in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way.

These explicit lessons are reinforced and enhanced in many ways:

Assemblies, Class Charter, through relationships child to child, adult to child and adult to adult across the school. We aim to 'live' what is learnt and apply it to everyday situations in the school community.

Class teachers deliver the weekly lessons to their own classes.

### **Relationships Education**

***What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?***

Relationships Education in primary schools will cover 'Families and people who care for me', 'Caring friendships', 'Respectful relationships', 'Online relationships', and 'Being safe'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

### **Health Education**

***What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?***

Health Education in primary schools will cover 'Mental wellbeing', 'Internet safety and harms', 'Physical health and fitness', 'Healthy eating', 'Drugs, alcohol and tobacco', 'Health and prevention', 'Basic First Aid', 'Changing adolescent body'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Healthy Me Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing adolescent body' strand, and in Jigsaw this is taught as part of the Changing Me Puzzle (unit).

Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

### **Menstrual Wellbeing**

The onset of menstruation can be confusing or even alarming for girls if they are not prepared. Pupils will be taught key facts about the menstrual cycle as part of statutory Health education from Year 4, including what is an average period, range of menstrual products and the implications for emotional and physical health. Sanitary bins are located in the cubicles in the Key Stage 2 girls toilets. Sanitary products are available in Lyndsey Kerswell's classroom. Lyndsey Kerswell and Sarah broom are our nominated adults for the girls to seek help from.

### **Safe and effective practice**

In order to create a safe learning environment ground rules will be agreed prior to any teaching and learning. The school values of respect and responsibility will be encouraged in every lesson. Distancing techniques will be used in lessons to help depersonalise the situations under discussion.

### **Answering Questions**

Sometimes an individual child will ask an explicit or difficult question in the classroom. Teachers have been informed that they do not have to answer questions of this nature directly, they can be addressed individually later. It may be that a child asks a question that is outside the remit of that year group's programme. In this case we will explain that we are saving this learning for later when they are a little older in school and also suggest that they could ask a parent/carer at home. The governors support individual teachers in using their discretion and skill in these situations and can refer to the head if they are concerned. Pupils will be able to raise questions anonymously by writing a question down to put in a box or by being sign posted to select adults throughout the school community.

### **Safeguarding**

We are aware that effective RSE brings an understanding of what is and what isn't appropriate. This can lead to a disclosure of a child protection issue. In instances such as this the designated safeguarding lead (Sara Pike) will be informed.

### **Sex Education**

The DfE Guidance 2019 (p.23) recommends that all primary schools 'have a sex education programme tailored to the age and the physical and emotional maturity of the pupils.

However, 'Sex Education is not compulsory in primary schools'. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and – drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

At St Margarets Academy, we believe children should understand the facts about human reproduction before they leave primary school so that they are able to make responsible and informed decisions.

We define Sex Education as understanding human reproduction.

We intend to teach this as part of our PSHE lessons.

### **Parents' right to request their child be excused from Sex Education**

"Parents have the right to request that their child be withdrawn from some or all of sex education delivered as part of statutory Relationships and Sex Education" DfE Guidance p.17

At St Margarets Academy, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle (unit). We conclude that sex education refers to Human Reproduction, and therefore inform parents of their right to request their child be withdrawn from the PSHE lessons that explicitly teach this. The lessons in the Jigsaw Changing Me Puzzle that teach human reproduction are as follows:

- Year 5, Lesson 4 (Having a baby)
- Year 6, Lessons 3 and 4 (Conception, birth)

The school will inform parents of this right by a PSHE curriculum letter in the Summer term before the Changing Me Puzzle is taught in Summer 2 with information on how you can go about withdrawing your child if you should wish to do so.

### **Monitoring and Review**

A working party made up of the PSHE leader, the head teacher and the school governors will monitor this policy on an annual basis. Serious consideration is given to any comments from parents about the PSHE (RSHE) programme and a record of all such comments is made. Governors scrutinise teaching materials to check they are in accordance with the school's ethos.

### **Equality**

#### **This policy will inform the school's Equalities Plan.**

The DfE Guidance 2019 (p. 15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics...

At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender), they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

At St Margarets Academy we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

We nurture positive and healthy relationships across the school community, helping all children to understand what makes a positive and healthy relationship and how to get help if they are experiencing something unhealthy. There is minimal focus on sexual orientation; only enough to enable children to understand the meaning of the words lesbian, gay, transgender and bi-sexual. This work is about alleviating misconceptions and stereotypes and about accepting and respecting all people. At no point during this work is there mention of sexual activity. There is no direct teaching about children themselves being LGBT, rather each child is treated as a valued individual.

For further explanation as to how we approach LGBT relationships in the PSHE (RSHE) Programme please see:

‘Including and valuing all children. What does Jigsaw teach about LGBTQ relationships?’

All responses to children’s questions about straight, gay and lesbian relationships should be dealt with factually and only relate to the emotional side of the relationship rather than the mechanics of the physical side of the relationship (with the exception of the biological aspect of reproduction). It is recognised that some children have gender confusion. This will be addressed if the need arises with support from outside agencies and with full consultation with parents. Gender equality will be promoted and any discrimination will be challenged. With the support of their parents, all pupils can decide which gender they identify with and to which pronoun they wished to be referred to by and which gender they are treated as.

### **Who will be responsible for providing Relationships, Health and sex Education?**

This will be led by the PSHE leader and in close conjunction with the head teacher and school governing body. Relationships, Health and Sex education will be taught by class teachers with the support of the PSHE leader. Teachers will be responsible for notifying parents before their children start this unit of work.

A working party will be made up of the PSHE leader, the head teacher and the designated school governor.

Teaching staff will receive training from the Jigsaw training providers. This will introduce the Jigsaw PSHE scheme of learning and have a specific emphasis on the new statutory Relationships, Health and Sex education guidelines.

### **Monitoring and Evaluation**

Pupils will have the opportunity to review and reflect on their learning during lessons through regular question and answer sessions. Evidence of learning that has taken place in a PSHE lessons will be seen in the class curriculum books. This will provide a snapshot of the learning and could include specific pupil comments, drawings, observations, photographs etc. The PSHE leader will carry out regular monitoring making reference to the class curriculum books and conferencing with the pupils about their learning in PSHE.

## Relationships Education in Primary schools – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

The guidance states that, by the end of primary school:

## Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
